Overview and Terms & Conditions

Welcome to the Naturally Healthy Photo Competition hosted by Active Devon on behalf of the Devon Local Nature Partnership, (DNLP) as part of the Naturally Healthy October campaign. The competition offers the opportunity to explore your local natural environment, take photographs with your phone or camera and submit them for a chance to win prizes.

The competition is open to people of all ages residing in Devon. Entries are limited to one photograph per person per category. Individuals will be able to submit their entries via an online link.

The competition will run from the 1st October 2020 – 31st October 2020 with two different categories for you to enter:

- **My Favourite Place to be Naturally Healthy**
- **My Favourite Naturally Healthy Activity**

We would encourage you to explore natural spaces near to where you live, like gardens, parks, woodlands, beaches, footpaths etc.

When out taking photos, your safety is your own responsibility so please take care and ensure you act according to current [government guidelines](#) regarding COVID – 19.

Terms and Conditions

- 1) The competition organiser is Active Devon on behalf of the Devon Local Nature Partnership.
- 2) The competition is open to people of all ages who reside in Devon, Plymouth or Torbay, excluding employees of Active Devon, DLNP and other organisations associated closely with the Naturally Healthy October campaign.

- 3) The entry process which includes completing an entry form, will be done via an online link issued by the organisers. The online link to the entry form will be widely shared on social media and via the Active Devon and DLNP websites. - 4) Please email your entry photo(s) to can@activedevon.org. Please include your surname and initial in the subject box, and the category you are entering in the body of the email. This will enable us to match your photo with the Active Devon Media Consent. Further details can be found on the online entry form.
- 5) No entries will be considered after the closing date.
- 6) Where the entrant is a young person under the age of **18** the parent/guardian is aware of the nature of the competition and takes responsibility for ensuring photographs are taken in a safe and appropriate way. Please ensure you are following the [latest government guidance](#).
- 7) Active Devon and the Devon Local Nature Partnership will judge all entries and their decision will be final. No appeals process will be in place.
- 8) Prizes will be awarded for 1st place and two runners up in each category.
- 9) Active Devon and the Devon Local Nature Partnership reserve the right to terminate the competition if circumstances arise that are out of our control.
- 10) We plan to publicly share the winning photos so will need to obtain the necessary consent as outlined below.
- 11) All entrants and any persons appearing in your photo(s) will need to agree to the media consent statements and conditions of use on the Media Consent form.
- 12) Where young people under the age of **18** are entering this competition, the parent/guardian is agreeing to be bound by the terms and conditions.
- 13) If the media/privacy consent has been accepted as part of the entry, we will not conduct any further checks before publishing photos. You can withdraw media consent at any time by contacting data@activedevon.org.
